

Description

The MAFR-000514-000001 is a single-junction circulator designed for radar. It operates over the frequency range of 3100 MHz to 3500 MHz. Insertion loss is less than 0.30 dB over an operating temperature range of -40 °C to +85 °C.

The MAFR-000514-000001 comes in an industry-recognized package designed for drop-in assembly.




Figure 1. MAFR-000514-000001 Block Diagram

A block diagram of the MAFR-000514-000001 is shown in Figure 1. The absolute maximum ratings of the MAFR-000514-000001 are provided in Table 1.

Electrical specifications are provided in Table 2. Plating information is shown in Table 3.




Figure 2. MAFR-000514-000001 Package Dimensions

Figure 2 shows the package dimensions.
