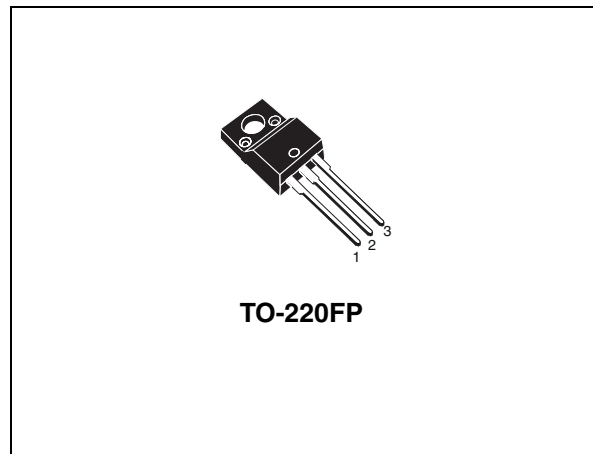


Figure 1. Internal schematic diagram

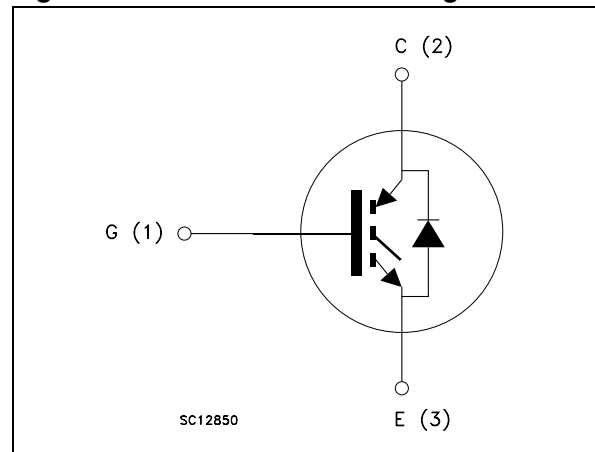

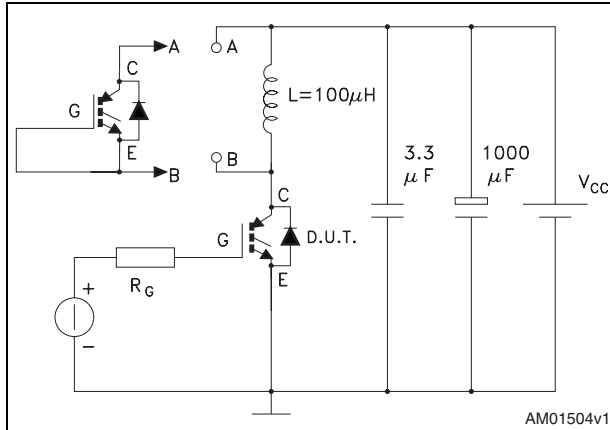

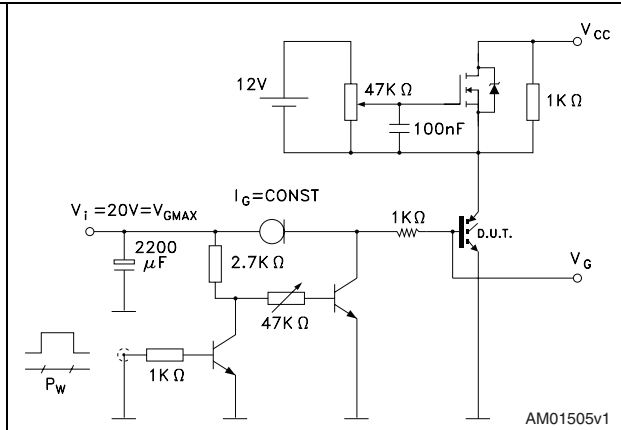

Figure 2. Test circuit for inductive load switching



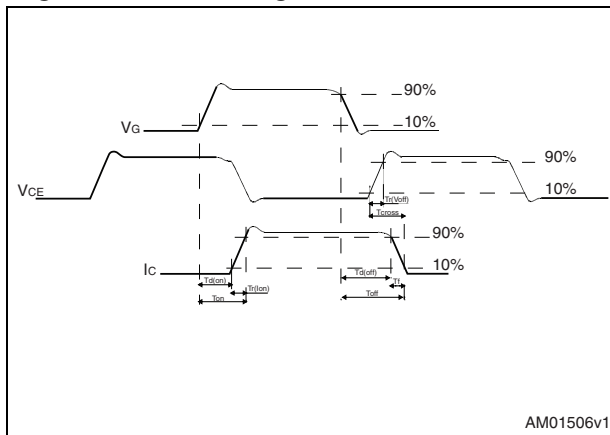

Figure 3. Gate charge test circuit



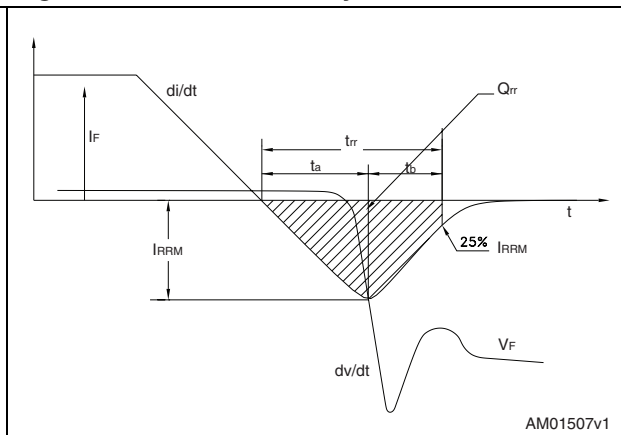

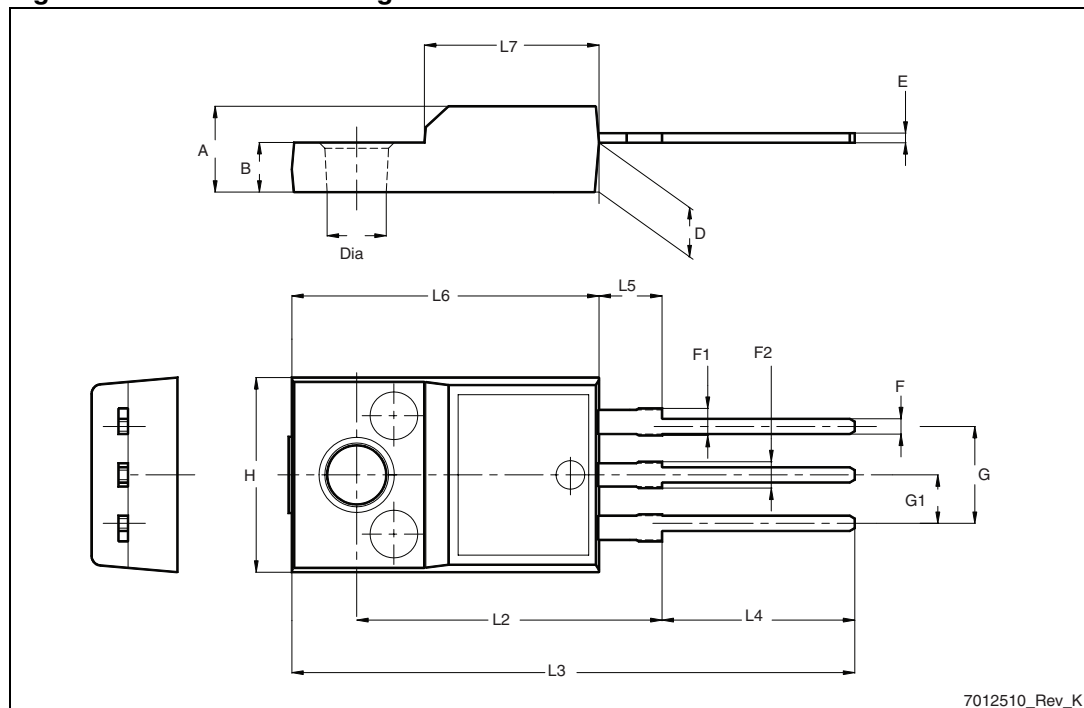
